

Introduction

Those who are opposed to the Illuminati often get hung up on wanting to resist the Illuminati or wanting to destroy the Illuminati, but this type of thinking is completely negative; you need to have positive goals. The Illuminati is a system that is dedicated to destroying democracy and Christianity. The way to eliminate the Illuminati is to promote democracy and Christianity. These are positive goals. But to promote Christianity, you have to understand who really was the historical Jesus. Who was Yeshua?

Growing up, the Christian Churches I attended often described Jesus Christ as a kind of Sunday School teacher with magical powers. He was like Harry Potter, only he preached moral lessons between the times when he performed his magical miracles. When I was young, there were certain things about Christian Churches I didn't care for. I didn't like the way that so many Christians were judgmental. And I found the stories of his miracles to be unlikely. Christianity seemed to me to be more of a system of behavior control rather than a system of spirituality.

The Church doctrine I was taught back then went something like this. "God is all powerful, all knowing and he created you to be born in sin. Thousands of years ago some ancestors of yours broke a commandment and so now all their descendants must be punished for a crime they never committed. God still loves you even though you're a bad person. God loves you so much that he sent his only son to Earth to be tortured to death so you would feel guilty about being so sinful. If you believe in Jesus and obey the Church (and give the Church lots of \$\$\$) you'll go to the happy place when you die, but if you don't--God will send you to a bad place to be tortured forever--amen."

It was only when I was older that I began to understand the difference between the indoctrination of my Sunday School teachers and the reality of what Yeshua actually did. I have come to appreciate the fact that the historical person of Yeshua was a true revolutionary. He was someone who effectively stood up to Luciferianism in many ways. And so even after more than two thousand years he is still relevant. I believe that you can't really oppose the Illuminati unless you understand Yeshua.

Yeshua was the first world leader to effectively stand up to Luciferianism. When I talk of Luciferianism I'm talking about an ancient system of mind control. This system goes back some six thousand years. It is the system by which a small group of aristocrats at the top of the pyramid can rule everyone below them. They make up a mythology, and then they use that to control the minds of the people, turning them into slaves of the state.

The story of the historical Yeshua that I believe in now as an educated adult is this:

"On May 20th, 1 A.D. a child was born to Joseph and Mary, they named him Yeshua. He was born in the time when Herod Antipas was one of the rulers of Judea. Many Jewish people were disillusioned with the dynasty left behind by Herod the Great. They wanted another king to unite and rule their lands. Both parents of Yeshua came from royal bloodlines by which their son might make a claim to be king of Judea. The people wanted a messiah to come to defeat the Romans and establish a just kingdom. However, Herod Antipas didn't want any challenges to his family's dynasty. So he sent men to kill the child, but Joseph, Mary and baby Yeshua escaped. They lived for a time in Egypt where Yeshua was tutored by wise men educated at the Library of Alexandria. When he returned to Judea with his family, Rabbis at the temple were amazed at his wisdom. There were those who then still believed that he might grow up to be the messiah. But Yeshua could not be betrothed because of political reasons. If he choose a wife from one powerful family, the other families would oppose him. But while he remained unmarried all of the powerful families in Judea might hope to form an alliance with him through marriage, should he actually become the messiah. His life was still in danger, both from Herod Antipas and the Romans. So Yeshua travelled up the silk trail to India. There were many Jewish merchants and communities on the silk trail. So by constantly traveling he could avoid assassination. While in India he was exposed to new cultures, philosophies and religious organizations. And all this gave him an expanded understanding of the world. He came to understand how Luciferian mystery schools ruled the people of the known world. In India he saw how respected holy men were often celibate, and having been that way himself for so long, he acclimated himself to that lifestyle. But he did not convert to Hinduism or Buddhism, he remained a believer in monotheism. When he returned home he was baptized by John the Baptist, who further educated Yeshua on the politics of that region. John the Baptist had started a spiritual-political movement which opposed the rulers of his day. After John the Baptist was martyred by Herod, Jesus became the head of that movement. For a number of years he preached and performed healing miracles. He spoke out against the corruption and materialism of his time. He promoted a lifestyle of spirituality. He could read the minds of people. He had insights into the future. And he used prayer to banish demons. He entered Jerusalem on a day that would later be called Palm Sunday, and the people of the city declared him to be the messiah. They were expecting him to attack the Romans or the corrupt priests of the temple, but instead he attacked the money changers at the temple. This has often been misinterpreted by Christian ministers as to its meaning. Even then Yeshua understood that the real rulers of his day were the Luciferians. And one Luciferian control technique was to manipulate society through financial scams. The money changers at the temple were Luciferians, but the Roman soldiers were not. So it made sense that he would only attack the money changers. It's also significant that the same scam that was being used by the money changers back then is still being used by the Federal Reserve today. Yeshua also knew that Herod the Great had built the temple to honor himself, not God. Yeshua knew that it was just a matter of time until the Romans sacked the temple. He wanted his teachings to be as a temple that could not be torn down. So he prophesied that the temple made of stone would be torn down, but his temple of wisdom teachings would be resurrected after his death. Later, Yeshua was predictably betrayed by Judas, and he was given a trial. Although innocent, he was found guilty. It was always the intention of Yeshua to become a martyr. He had seen how the murder of John had motivated his followers. Yeshua wasn't going to make the mistake of attacking Rome in a military conflict which they would certainly win. Instead he created an army of spiritual followers whose greatest warriors would become non-violent martyrs. Yeshua was crucified on a cross before witnesses. He was declared dead by the Centurion Longinus. His

wounds were dressed and he was placed in a tomb. He arose days later. His closest followers saw that he had been crucified and yet still lived. All of this was according to God's plan for Yeshua. This made Yeshua the messiah for all people. There are many mythological stories from that era of history which have similarity to the story of Yeshua. But Yeshua was a real man, not a mythological character. So peoples of differing religions came to see him as the true fulfillment of their own desire for a spiritual liberator. Although Yeshua miraculously survived crucifixion, his wounds were still great. He died some weeks after his resurrection. After the death of Yeshua, his brother James the Just founded the first Church based on Yeshua's teachings in Jerusalem. Stories of the teachings of Yeshua were recorded in letters there. Early followers of Yeshua came to Jerusalem and made copies of these letters. These copies became the basis for the Four Gospels. After the fall of Jerusalem to the Roman Army, the other early Christian Churches used their copies of those writings as a basis for their faith. In the process of copying these early Christian writings, there was some alteration of the teachings of Yeshua, but his basic message could not be completely suppressed. A religion based on those Gospels has spread throughout the world. Today it is the largest religious movement in the world. And the Luciferians of our day seek to destroy that religious movement. The Illuminati understands that they can't have complete world dominion unless they destroy the teachings of Yeshua. And so the battle against Luciferianism which Yeshua began two thousand years ago is still being fought. This is the true story of Yeshua."

Unfortunately, many modern Christians fail to understand that Luciferianism actually still exists. They fail to understand what it is. The Illuminati remains as invisible as it needs to, and it manipulates Christianity and all the other world religions. Christians are kept in various ways from empowering themselves to defeat their Luciferian overlords.

But I believe that the spirit of Yeshua has come back to this world. Other people are awakened to the fact that the Illuminati exists and that it is doing terrible things to this world. Like Yeshua, there are many who are preparing to attack the money changers at the temple. The tricks used by the Luciferians are no longer fooling everyone. The war against the Luciferians which Yeshua started will be won by this generation.

Section One, World War Three

First I will address the subject of WWIII. In a book published in France in the late 1890s there is an account of a plan for three future World Wars; this plan was attributed to Albert Pike. That book's French author (sometimes known as Taxil) would later announce to the world that all of his books were hoaxes--after which he then mysteriously retired in wealth. The curious thing is this, World Wars One and Two would eventually take place exactly as described in that book published in the late 1890s. Only a fool would think of this a coincidence--years before WWI and decades before WWII there was published accurate plans for these wars. These accurate plans were attributed to Albert Pike, the only man in the world at that time who had an intellect which could have conceived of such plans. Any person of wisdom knows that World Wars One and Two were based on plans created by Albert Pike for the Rothschilds.

The Global Plutocracy, the New World Order, the Illuminati, the Globalist Elite--those who make their secret plans and use their great wealth to impose those plans upon the world--they have followed the planning of Albert Pike thus far. However, there is something that these grand wizards who secretly rule the world fail to realize. If they go forward with WWIII, they destroy themselves in the process. This below is the plan for WWIII.

The Third World War must be fomented by taking advantage of the differences caused by the "agentur" of the "Illuminati" between the political Zionists and the leaders of the Islamic World. The war must be conducted in such a way that Islam (the Moslem Arabic World) and political Zionism (the State of Israel) mutually destroy each other. Meanwhile the other nations, once more divided on this issue will be constrained to fight to the point of complete physical, moral, spiritual and economical exhaustion... We shall unleash the Nihilists and the atheists, and we shall provoke a formidable social cataclysm which in its horror will show clearly to the nations the effect of absolute atheism, origin of savagery and of the most bloody turmoil. Then everywhere, the citizens, obliged to defend themselves against a world minority of revolutionaries, will exterminate those destroyers of civilization, and the multitude disillusioned with Christianity, whose deistic spirits will be from that moment without compass or direction, anxious for an ideal, but without knowing where to render its adoration, will receive the true light through the universal manifestation of the pure doctrine of Lucifer, brought finally out into public view. This manifestation will result from the general reactionary movement which will follow the destruction of Christianity and atheism, both conquered and exterminated at the same time.'

Of course there are those who would say that we are already in WWIII; and it's true that we are in a world war which began with the false flag operation of 9/11/2001. And future historians will describe all the fighting being promoted around the world at this time as WWIII. However, if we were to interpret Albert Pike's plan literally--this fighting that's still going on would continue to go on and it would escalate into an apocalypse. The complete destruction of both Israel and Islam would mean the death of millions of human beings. If Christianity were to be literally beaten into submission through war, there would be even more millions killed. If the atheistic Communist China were to be destroyed with war, even more millions killed. Some members of the Global Elite think that WWIII should end when there are only a half a billion persons left alive on the world. So we are talking about the killing of more than six and a half billion people to achieve a literal interpretation of Albert Pike's plan for WWIII. Then, according to present day Illuminati leaders, a New World Order government, perhaps run by the Rothschilds and Rockefellers, would be established to lord over what's left of humanity. In this literal interpretation of Pike's plan the result would be a world consisting of slave-owners and slaves. Without a doubt, such a world would not be a utopian paradise but rather a living Hell for everyone.

Nevertheless, in reality, such a plan would never actually work, no matter how detailed the planning and no matter how well funded the planners. If the Illuminati were to literally take this present world war to the extent that Albert Pike described, it would only result in true chaos leading to the destruction of all humanity. There would be no way to stop the massive destruction once the slaughter of billions of human beings began. There are those who think that in the near future, perhaps on 3/22 of this year, a war of annihilation will begin--leaving behind a landscape of Skull and Bones. This would be planned as

a controlled demolition of humanity. However, the problem with the idea that there can be a controlled global holocaust is that once it starts--nobody would actually be in control. There are two reasons why I'm certain that this literal interpretation of Pike's plan for WWII won't work.

First, the soldiers and politicians who the Illuminati leaders would rely on to carry out the plans of mass murder would be driven insane by what they would be forced to do. This is true even of sociopaths who have never before shown remorse for taking human life. Those of superior intellect know that on a subconscious level of mind all human beings are interconnected. Right down to the level of quantum physics, we are connected to one another. There is a collective unconscious which psychically connects all people together. It operates on the principle of quantum nonlocality. The massive killing of billions would traumatize the psyches of everyone on the planet. This would cause mass insanity that would result in true chaos. There would be no safe place where anyone could hide from this. This mass insanity would make everyone unpredictable. The chaos that would follow would result in the death of every human being.

Secondly, there is the issue of Situational Loyalty. This principle of social organization can be best explained with a thought experiment. Imagine that there are 13 sailors in a life boat. They've abandoned a sinking ship, leaving the passengers behind to die, and they are rowing together toward a nearby island. While they are in the same boat, they are loyal to one another. None of them want to capsize the boat, whereupon they would all drown. So they express friendship to one another and work in cooperation. Their loyalty is to one another--until they reach the island. Once on the island their situation changes. Then they fight with one another over limited resources. Eventually they all become mortally wounded. As the last of the 13 dies on the island, the ship they abandoned sinks beneath the unforgiving sea.

This is the problem with the New World Order and its plans for global government--it starts and ends with betrayal. First the wealthiest families in the world unite in their betrayal of the rest of humanity--then once the situation changes, when that global government finally does become predominant, the wealthy betrayers (predictably) turn on each other in the quest for absolute power. Finally in the chaos of that struggle--the weapons of mass destruction will be used. There will be no place of safety for anyone--not the Ghost Cities of China, not the Deep Underground Military Bases, not the private bunkers, and certainly not the FEMA camps. There would be no chance of survival for anyone. We are at the point where the world's leaders must realize that Albert Pike's plan for WWII cannot be interpreted as a literal war of marital combat. The time to end all wars of violent conflict has come right now. This is because we have finally reached the exact point where we will either now end all war--or humanity will completely destroy itself.

The truth is that a democratic republic which guarantees human rights to all its citizens is the only shield that can be counted on to protect anyone. This is true for the wealthy and powerful as well as the middle class and the poor. If the Shield of Democracy is broken--nobody will be safe.

When I was young, some Illuminati members who believed I had a certain ancestry wanted me to learn the Keys of Solomon magical rituals. These go back to Medieval times and possible even back to the Templars. Supposedly ole King Solomon used rituals and sigils to command demons. I never went in for this kind of stuff. Although I'm not a dogmatic Christian, I'm still resolute about sticking to Christianity. After praying to the one God, I might occasionally invoke the help of a friendly angel, but I've no use for demons. I believe that if you invoke them, they might do your bidding for awhile, but eventually you would become their slave.

I point this out because this plan for WWII is inspired by demons. Only a reptilian alien hostile to all humanity would want this plan to go forward. But it's not enough to oppose the Illuminati, you must be in favor of something. In terms of government, the only type of government I can favor is democracy.

Section Two, Scientocracy

The science of democracy is Scientocracy. What will be described here is a practical form of international government. This is a type of international government that could last indefinitely--for as long as humanity exists. Imagine that the human race were to expand beyond the Earth. Imagine that humanity fills the solar system and then expands out into the galaxy. Imagine that a future is possible where there are countless worlds where trillions of human beings live in peace, prosperity, and harmony. Imagine that humanity, over a period of more than a million years, governs itself in justice, enlightenment, and loving fellowship. If you can imagine this, then you should know that Scientocracy would be the type of government which would make this bright vision for the future possible.

Although the word "scientocracy" is at the present time a neologism, it is, nevertheless, somewhat in use. The most common definition is that Scientocracy is a government based on science. I will give it a more exacting definition.

Scientocracy: A democratic republic that is ruled by citizens who have been educated in the sciences. To make this clear, let's define what it is not. It is not a scientific dictatorship. It is not a modernistic form of plutocracy. It is not a group of technocrats who serve the ultra-wealthy. It is not a government made up of soulless bureaucrats who believe in scientism.

Scientocracy is the use of scientific understandings to create a form of democracy that is practical as well as beneficial for its citizens and their children. Scientocracy is concerned with the welfare of both humanity and the ecosystem within which humanity must survive. Scientocracy is a democratic republic ruled by citizens who have been educated in the sciences; these citizens elect representatives who serve their will; and those representatives govern all the people.

Because science itself is an ongoing system of discovery, the subject of Scientocracy must be open to evolution. It must be a subject matter which can change over time. I would not hope to cover the subject in its entirety, but I think I can help describe some of the basic dynamics.

Principle #1. Democracy must be authentic in order for it to be stable. Democracy is a form of government in which its citizens elect representatives to govern society. The United States of America started out as an authentic democracy. However, it now is, on a Federal level, a fake democracy. If you are to be brutally honest, you have to admit this. Right now, Washington DC responds not to the will of the people but only to super-wealthy interests. It is the lobbyists, Wall Street, and

the Bilderbergers who are telling the politicians what to do. In truth, Americans are being taxed without authentic representation in government. This illusion of representation may keep most of the peasants calm, but it can only result in the eventual breakdown of the system as things worsen. Those who wish to create an all powerful global government are counting on such a breakdown. But such a breakdown would mark the beginning of the end to the world. To make the USA stable again, it must be restored to authentic democracy.

Principle #2. The less the government interferes with the lives of individuals the more stable that government actually is. I realize that this statement sounds counterintuitive, but actually it's true. Chaos Theory shows that there is always an underlying order at the foundation of every seemingly chaotic system. The behavior of groups of people is more predictable than the behavior of individuals. If you try to control people on an individual basis you will only create a society which is actually a prison system, and the people will always resist this type of control, thus creating instability. If you leave individuals free to make their own choices and force them to take responsibility for those choices, you avoid this type of resistance. Social engineering should not be on the level of the individual but on the level of the crowd--it should be directed at mass psychology. Propaganda can be used to direct the overall behavior of people by encouraging certain social trends. It doesn't matter if everyone goes along with the propaganda or the social trends. Enough people will respond to this type of social engineering to make society manageable. The minority of humans who remain highly individualistic won't be able to interfere with the direction in which mainstream society will take. Thus a belief in human rights and individual freedom isn't idealistic, it's ultimately pragmatic.

Principle #3. Truth itself is the most powerful form of propaganda. In order for citizens to be effective as voters, truth must be allowed to be expressed through the mass media news. And truth must be taught in schools. Of course, this is not the case right now. There has never been a time in the history of the world where so many people have been subjected to so much falsehood. This has turned the average citizen into a sheeple idiot. But sheeple idiots do not make effective citizens, they are really only problems for society. Once you reject a depopulation agenda as the solution to the problem of having a society made up of sheeple idiots, you began to realize that the public needs to be given a heavy dose of reality. That means that the mass media news outlets have to start telling the truth, and eventually true human history has to be taught in schools.

Principle #4. Diversity is good. Complexity theory shows that complex systems are often more stable than simple ones. There is a wrong-minded theory of Global Government in which society is to be made simple. [Only one government. Only one currency. Only one language. Only one religion. One monolithic global culture. Complete centralized control of everyone and everything.] Even if such a government could be achieved, it would only last a short time. It's simplicity would make it unstable. Think about the centralized control of the Soviet Union. How stable was that government? It's suppression of diversity caused its instability. Diversity creates stability. This is because diversity creates a natural balance of power. And a balance of power is essential to governmental stability. There should be many nations, many languages, many currencies, many races, many religions, and many cultures.

Principle #5. When it comes to international governance, standardization of government-type is better than centralization. Instead of a single all powerful Global Government there needs to be an International Alliance of Democracies who use treaties to create international governance. These alliance nations would all be independently sovereign, however, through treaties they would all agree to utilize a standardized form of democracy. Through standardization, a decentralized form of internationalism would emerge. This can be achieved through an alliance of democratic nations rather than a centralization of power. Imagine a group called the Democratic Allies Treaty Association or D.A.T.A.. This would be an open forum for democratic republics who have attained a standardized form of democracy. Any nation refusing to conform to the standardized form of democracy would be boycotted, harassed and exploited by DATA member nations until that rouge nation agreed to become a standardized democracy. The people of each newly recruited member nation would be ruled by their own elected leaders. Then and only then, do they become a member of DATA. In this way democracy can be used to liberate the world one nation at a time. (Yes I do know how controversial this sounds.) However, DATA would not be an all powerful centralized government, but a forum in which independent democratic allies create treaties. And such treaties would be formed on the basis of data analysis. DATA would be the means through which the world leaders educate the public so that they understand the necessity of certain treaties. DATA would not need a president because it would not be a government. It would not have its own army, nor would it even have a building. It would exist only on the internet and the process of treaty creation would be done openly. After WWI there was the League of Nations which the people of the world rejected. After WWII there was the U.N., which will be disposed also because of its abuses. After WWII there will be not be a world government. The Illuminati will be destroyed. Instead of the lies of the New World Order their will be DATA.

Principle #6. Voter-Qualified democracy is necessary in creating an intelligent government. We have a culture that is dependent upon science and technology. Therefore an intelligent democracy requires voters who understand science and technology. But these days the general population refuses to train themselves in the basic sciences. In order to qualify to vote, a citizen must take a test to prove a basic understanding of the sciences. This would not just be the hard sciences such as math and physics but also social sciences such as psychology, sociology and political science. The Qualified-Voter would not be expected to be an expert on any of these fields, but should understand the relevant basics, especially as they relate to politics. Those who do the testing must be made to be above corruption.

Principle #7. Candidates must be qualified before running for office. Consider a process which works something like this. A candidate, in order to register an intention to run for office, must have a petition of supporters. The higher the office, the more names required on the petition. This petition would be online. Then the government would do an initial vetting, before the results of the vetting would be published, the candidate would be shown the results of the investigation and given a chance to refute any stated facts in it. This vetting would show things like criminal records (if such exist), history of mental illness or substance abuse, service in the military, employment record, educational record, and birth information. The government would have an independent branch which vets candidates. The further on in the process of getting elected, the more intensive the

vetting would become for the candidate. And all verifiable facts would be systematically revealed to the voters. This way there would be no last minute surprises. Furthermore, at some point in the process of running for office, the candidate would have psychological testing, medical tests, and IQ tests--all of which would be made public. The voters would know exactly what type of person is running for office. Also connections to secret societies or corporations would be revealed publicly. This is a quality control factor for democracy--ensuring that the people get the highest quality representatives--rather than the lying, degenerate scum who now hold office.

Principle #8. Government officials must be monitored by an independent internal affairs. There would be an independent branch of the government which would investigate the elected politicians as well as high ranking appointed officials. This internal affairs would look for corruption. This would be a professional watchdog group to monitor government leaders for the purpose of eliminating corruption. Congress would not be in charge of investigating itself. The government would not be trusted to investigate itself. However, there would have to be checks and balances in the system to make sure that the Candidate-Vetting Branch of the government and the Internal Affairs Branch of the government can't abuse their powers. So congress would have the right to investigate and challenge these new branches of government.

Principle #9. There must be no PACs, corporate, or foreign campaign contributions allowed. There must be limits placed on how much money a politician can spend on a campaign. All contributions should be from private citizens, and no severe limit should be placed on how much can be contributed by a private citizen. This would give a certain power to the wealthy who could promote the candidates they want with campaign contributions. However this too would be a check and balance of power. Populous leaders can't always be trusted. For example, Hitler was a populous leader. Wealthy campaign contributors would not be able to dictate who runs for office, but they would be able to influence the process, and this would not necessarily be a bad thing. What most wealthy aristocrats want is stability, and once a government has risen above corruption, stability would be a good thing.

Principle #10. The wealthiest and most powerful citizens must be monitored and protected by a benevolent panopticon. Government protection for the wealthiest taxpayers would be required. This would be a part of a new way of thinking about the symbiotic relationship between the wealthy aristocrats and the democratic government. The aristocrats would be protected, but also, within reason, observed by the government. This way secret societies among the wealthy which might undermine democracy could be prevented. No secret societies would be allowed which would undermine democratic processes. This would not be the end of individual privacy, but the end of organizational privacy. The Bilderberg Group could still meet, but the meetings of its steering committees would be open and available to the public. Wealthy aristocrats who meet in secret and plot against the government's sovereignty could be found guilty of treason.

Principle #11. All democratic nations need to have a Department of Environmentalist Information. This would have the right to investigate the causes of environmental problems such as pollution and to also indicate realistic solutions. This department would have the responsibility and power to inform the public about the truth of environmental issues. This department would be free from corporate control or censorship. It would also indoctrinate the public as to their role in protecting the environment.

Principle #12. Parent-Qualified population control is essential in the future of democratic republics. The government would not forbid anyone from having children; however, the government would only provide financial child support for those couples who qualify as parents. This would be a powerful motivation for couples to achieve Parent-Qualification before planning to have children. An assumption to this is that young citizens will be required to be indoctrinated from childhood on so that they know the techniques and responsibilities of birth control. Propaganda and education must be used to put a virtual end to unplanned pregnancy. Qualified-Parents would receive funding for all aspects of raising a child who has been authorized by the State. Although anyone who wants to could have children even without Parent-Qualification, they would have to be able to pay for all the costs of the birthing process and raising the child from birth until the age of adulthood at eighteen. This wouldn't affect the wealthy, but would make the average couple feel that they must achieve Parent Qualification before planning a family. Presently public education is free for children, but adult education costs the student money; in the future this would be the opposite. A couple who has achieved Parent-Qualification would have all educational expenses for their child paid for by the state. A couple who does not have Parent-Qualification status would have to pay for all education costs for the child as well as all other costs--healthcare, food & shelter and so forth. If a mother has a child and can't pay for all the required costs, that child can be taken away and put into a foster system until the mother can achieve a higher income level. If such an income level is unattainable, the child will be put up for adoption to a couple who have attained Parent-Qualification. (Yes I do know how cruel this would be to the parent, but children should come first.) Parent-Qualification would not be a matter of eugenics. There would be no attempt to achieve genetic purity of any kind. It would be the known behavior of the couple applying for Parent Qualification which would be analyzed. And only stable couples would be allowed to apply for Parent Qualification. The background of the couple applying for Parent-Qualification would be examined in detail. Persons could be disqualified for things like substance abuse, criminal background, mental health issues, poor employment, and a failure to pass testing for psychological factors indicating good parenting skills. Gay couples would not be excluded from qualification. Propaganda would be used to discourage those who fail to qualify from having children. This would not give the government complete control over the size of the population, but it would be able to influence population size as much as necessary for the purposes of treaty fulfillment. Democratic nations, for the purpose of environmentalism, would have treaties made whereupon they would agree to regulate population size in their countries. This would be a more benevolent way of regulating population size than the use of war, famine, and disease. The use of tax dollars to fund Qualified-Parents would be justified to non-parent tax payers by pointing out that the quality of citizens is determined by how they are raised as children. The future of any nation is in its children.

Principle #13. Interfaith Spirituality must be deliberately promoted to change the nature of human culture away from materialistic consumerism and toward true enlightenment. This means tax free status for religions and non-profit spiritual organizations which qualify. Those groups who achieve non-profit status must be monitored by government to insure that they

serve a purpose that benefits society.

Principle #14. Environmentalism and adult science training must be promoted in a way so that it becomes a responsibility of citizenship. In the future, the average citizen will think of himself or herself as a science-trained environmentalist. This identification of oneself as a science-trained environmentalist must matter more than religious preference. Adult education in the sciences and in environmentalism must be provided for free. Citizens who have higher levels of such training will qualify for a reduction in taxation. Unemployed persons should be paid to attend classes and earn certificates of training. This practice can be used to improve the overall job skills of workers in society.

Principle #15. The balance between socialistic aspects of the government and the use of private agencies should be understood. Certain services which provide welfare for the citizens in general should be provided by government. These would be things like the military, space colonization, the issuance of currency, public transportation, public adult education, libraries, welfare for those unable to work, and basic health care. Advanced health care may not be provided to all persons by the State. This would mean that wealthy persons and those who have better work insurance would have better health care. But all citizens would be given a basic level of decent health care for free. Private companies may be hired to provide any of those services which the government would guarantee to the people for the general welfare. But any private companies hired would work but under a system which is freed from corruption. And those privately owned agencies not run or hired by the government would still be subjected to government regulation. A basic principle for government regulation must be understood, the bigger the influence a corporation has on society the greater its regulation by government. The government would regulate small businesses as little as possible and big business as much as possible. Corporations would be allowed to make profits, but their responsibility to society would also have to be a factor in how they operate. Any person of wisdom knows that the French Revolution, the Napoleonic Wars, the Civil War, and World Wars I, II, & III were all engineered by International Bankers. This type of abuse of power must now come to an end, and democratic republics must be the ones who regulate all financial institutions for the public welfare.

Principle #16. Space Colonization replaces the military industrial complex as international peace prevails. That which fails to grow and evolve will stagnate. And that which stagnates will die. The expansion into space is a human need. Humanity, having given up the social structure that war imposes upon the population will need a new structure. The expansion of humanity through space colonization isn't just a nice idea, it's essential to survival. The corporations which now serve the military will evolve over time into space colonization corporations.

Section Three: How to conduct the Revolution

In order to conduct a revolution, you need a people. There are two groups of people in the USA who have reason to oppose the Illuminati, Christians and patriots, and the Illuminati intends to kill off both of these groups. But these groups must be reached with the truth. They must be made aware that they must become a part of the Truther revolution. The survival of Christianity and democracy depends upon this. The purpose of such a revolution can't merely be to destroy the Illuminati, it must also be to build. In the wake of the destruction of the Illuminati a new civilization must be built. This civilization needs two things, an effective secular democracy which complements a spiritual society. Christianity and democracy complement one another. This must be understood, you can't have one without the other.

Although some violence always accompanies widespread social change, I am not proposing violent revolution. Nor am I suggesting criminality of any kind. The Civil Rights movement effectively used civil disobedience, and although such was done honorably in that movement, even that type of criminality is unnecessary. This is to be a Truther Revolution. First this revolution of truth needs to be realized by those in positions of power to affect change. Then the Truther Revolution is to be spread to the masses. First the Truther Revolution will liberate America, then it will liberate Europe, and finally it will liberate the whole world.

For a Revolution to be successful there must be a scapegoat. In the first American Revolution it was the British. In this second American Revolution the scapegoat will be the Satanists. This makes sense because Satanists actually are to blame for all the world's problems, so they will be the perfect scapegoats. Satanists in secret societies will be blamed for everything. It will be revealed to the public that a cult of Satanists have taken over positions of power around the world. Their intention to destroy the world will be exposed. There are people who have made the mistake of publicly exposing themselves as Satanists, they will be forced to openly renounce Satanism or be subjected to incarceration. However, this should not really be about attacking persons. This blaming of Satanists is metaphorical in a sense. Everyone in the culture of the USA and Europe is familiar with the teachings of Christianity--this is true even for non-Christians. A case can be made that Satanism is to blame for all of society's failures. The government will remain secular, but the people will be made to understand that a return to certain Christian values is essential to the reform of society.

Although some Freemasons are Satanists, it should be understood that Freemasonry isn't exactly the same as Satanism. There are Satanists at the top of many types of organizations, and this is true of Freemasonry, but that doesn't mean that all Freemasons are Satanists. I think that you must be very careful about who you accuse of being a Satanist. This can't be turned into a witch hunt.

There can be no effective transformation of the government without the intention of using amnesties and pardons to forgive criminal behavior. The present system is so corrupt that if you eliminate or jail everyone who's guilty of something, you'd shut down the whole government. Those who cooperate with the change should be rewarded with amnesties or pardons. This will not only make the transition easier, it will make the transition possible.

Whoever is allowed to speak the truth through the mass media outlets will become a hero liberator. So a lot of thought will have to be put into choosing these spokespersons of truth. Furthermore, there need not be only one spokesperson. The more people speaking Truther issues to the public the sooner people will wake up. Those who most effectively speak Truther issues must also be the ones who explain the related solutions to the public. The shock of hearing the truth will make the public

receptive to accepting solutions from those who speak the truth. The average person will become emotionally traumatized during the time when revelations concerning the Satanic holocaust are finally made public. This shock of discovery will make the public receptive to widespread change; this widespread change will come about through guidance from those Truther spokespersons who themselves receive inspiration from their newly achieved Christ Consciousness. However, on the level of the media, the Truther Revolution must be appropriately managed, so that these Truther Issues are presented in an orderly way. A controlled dialectic in the media should take place. This should be done so that as each Truther revelation is presented, the public is lead to certain intended solutions.

Truther Issues:

9/11 Truth: Start with Building Seven and show that it had to be controlled demolition and that such could only have been engineered by high ranking persons in the US government. From there, show up other problems with the government's story. Show the history of false flag operations in the US to make it clear that 9/11 was one.

Solution: Pass laws making all false flag operations in the US illegal. These laws should be so strict that even a government official proposing a false flag operation can be arrested. To avoid fanatical resistance from within the present establishment, Bush and other high rankers involved in 9/11 should be given presidential pardons and amnesties; however, a couple of low ranking persons involved with the attack should be charged with treason and publicly executed by firing squad--the video of which will be shown on TV and the internet. Some representative of the old regime, one of the powerful recipients of these 9/11 pardons, should be given a chance to justify their actions--saying that the threat of Islamic terrorism was real and that the War on Terror was a pre-emptive way to stop terror attacks before they actually began, thus saving more lives than what were sacrificed in the 9/11 false flag operation; in other words the old regime spokesperson will say that the Bush administration sacrificed three thousand Americans in order to save million of American lives which would have been lost if proactive military actions had not been taken. This justification will allow those powerful persons who receive pardons for their involvement in 9/11 to save some face--which is why they will eventually cooperate with this transition of power. However, the two presidential Bush family members will nonetheless lose their access to classified information. Also the War on Terrorism ends. The US does not invade any more countries in the name of 9/11 or non-existent weapons of mass destruction. Then laws will be passed restoring the Constitution. Thus it will take an act of Congress to declare war. The difference between small military actions, which a Commander in Chief may authorize for defense, and a war requiring Congressional approval must be clearly defined. All the special powers that Obama has given himself in the name of the War of Terror are to be repealed. The Patriot Act is repealed. The Constitution is restored so that the NSA has limits on its ability to spy on the American people. The idea of Voter-Qualification will be planted in the public's mind by suggesting that a society of science-trained citizens wouldn't have been deceived by the false flag operation because they would know about the speed of gravity and so forth. However, Voter-Qualification shouldn't be pushed at first--this idea must be allowed to slowly grow in the minds of the public.

Chem Trails: Show how Satanists in the Military used pedophilic sex rings to seduce and blackmail high-ranking Air Force officials so that the Chem Trail spraying could take place. This Chem Trail spraying is part of the Satanist's depopulation agenda. The Chem Trails started long before the Global Warming campaign, but Global Warming was used to get cooperation from persons in the Air Force and government who were deceived into thinking that the Chem Trails were a cure to Global Warming. It will be revealed that a small group of Satanists were able to take over the minds of government officials using trauma-based mind control with the intention of engineering the death of all humanity. This was done out of a Satanic hatred for all of God's creations and all of God's children. The entire Satanic depopulation agenda will be exposed.

Solution: Put an end to Chem Trail spraying, fluoride in water, and GMO foods. Other depopulation methods, such as plastics poisoning, will be gradually screened out. The shock of these revelations should be used to promote real solutions to overpopulation. A controlled dialectic will take place in the media: thesis--the Satanic depopulation agenda was accepted by some leaders as a solution to the real threat of overpopulation; antithesis--depopulation through war, famine, and the spread of disease is cruelly insane and must be stopped now; synthesis--a humane way to control population size needs to be developed. This is a way to promote Parent-Qualified population control. It can also be used to promote environmentalism and science training to the general public.

Federal Reserve: The history of how the Fed came into being and how it is actually being used must be made spelled out to the public. They must be made to see that criminality was used to establish this type of fraudulent banking system and that the government is a slave to the Fed so long as it exists.

Solution: The Fed must be transformed from the private institution that it is now into a branch of the government whose leaders are elected. One way to do that is for the Fed to stop printing new money. It's existing currency would be considered valid for as long as it exists. The government already has the right to mint coins without using the debt-based currency of the Fed. So as new money is needed, a type of smart coin is issued at all levels of currency--\$1, \$5, \$10 etc.... Smart coins would be thin plastic strips with electronic verification somehow built-in. The debt owed to the Fed by the US government would be forgiven in exchanges for pardons and amnesties which forgive the acts of treason (and other criminal actions) that have been perpetuated by those who own the Fed. This would reduce much of the Natl. Debt. Money that the government owes. More needed income for the government would also be raised by taxing certain types of derivatives on the Stock Exchange. Eventually after the economy has stabilized, the Fed would be formally turned into a branch of the government. In time, paperless currency and smart coins would replace paper currency, but this future should not be forced prematurely.

Obstetrical Abuse and circumcision: It will be shown that Nazi war criminals from Project Paperclip and Satanists are responsible for institutionalized obstetrical abuse and the medical practice of circumcision.

Solution: The reform of obstetric practices and the end of circumcision must take place for the benefit of mothers and children. This will also open the excuse to promote Parent-Qualification as a way to ensure that children are treated well.

Drug Dealing by the Government and War Creation by International Bankers: How the CIA and corporations have been involved with drug dealing will be exposed. Troops will be brought back from Afghanistan. International Drug Trade will be

ended.

Solution: Widespread drug addiction treatment has the potential to become a source of reeducation on a broad scale. Former criminals and addicts can be reformed into a sober work force. The ending of the drug trade will require the reform of the international bankers who launder drug money. Cooperation from the international bankers will be bought with amnesties and pardons for those who go along with the reform. This will create the excuse to engineer a stable global economy based on international treaties. It will also mean that the practice of international bankers engineering wars will come to an end.

Government Coverup of UFOs: Most of the UFOs that people have seen are prototype experimental craft built by the government. SETI was a government scam to confuse the public with disinformation; radio wave messages can't reach other solar systems because of entropy. However, advanced remote viewing has shown that alien cultures in space and on other planets do exist. Some of these alien cultures are friendly but some are a potential threat to humanity.

Solution: The energy technology being suppressed by the government which is being used in some of these UFOs must be made available to promote nonpolluting energy sources. The idea must be planted in the minds of the public that extraterrestrials might someday invade our planet. Therefore we must put an end to war between human nations and start channelling resources into space colonization.

MK Ultra and Monarch Mind Control: These practices must be forbidden by law. Also the so called transhumanist practices of genetic engineering and brain implants must be stopped.

Solution: As the public is educated to the extent to which they have been subjected to mind control and being dummied down, a case can be made for Voter-Qualification. If average people have been so stupid to be deceived to such an extent, are they really qualified to vote? At first Voting-Qualification will work like this, only those persons necessary to the rebuilding of the post-Revolutionary society will be allowed to vote. The military, the police, government personnel, medical personnel, and selected others will be granted the vote as they are considered essential to society. But a system for training citizens to pass tests which qualify them to vote should soon be established. This will prevent protests against Voter-Qualification. And the training system for helping people to pass the test will be used as social indoctrination. Apathetic persons won't bother to qualify themselves. However, those who do go to the trouble of becoming Voter-Qualified will be actively involved in government in a way that is necessary to a vibrant society. This freedom of mind isn't something to be feared. Actually free people are predictable (as Games Theory shows) because they seek their own best self interest. The government's job is to show citizens how cooperating with the government serves each individual's best self interest. A government doesn't have to regulate every aspect of human behavior if it has the ability to predict it.

Corporate Exploitation of the Environment: The way that Corporations have been allowed to destroy the environment in the name of profits must be shown in startling detail. Corporate Greed, Austrian School Economics, and Consumerism must be shown to be the blame for the destruction of the environment. It will also be shown that to protect the environment some regulation of population size must take place, and this can be used to promote Parent-Qualification. (I've heard from experts who's judgement seems valid to me that the Earth can survive with seven billion people on it if changes are made to bring humanity back into harmony with the ecosystem.)

Solution: Environmentalism means the end of consumerism lifestyles. It means a change from industrial farming to sustainable farming. It means an end to planned obsolescence in manufacturing. Everything must be recyclable. Energy management must be promoted. Non-polluting energy sources, which are currently being suppressed by government at the behest of the oil and coal companies, must be released and developed. Society must be decentralized. People will remain connected through the internet but will move away from densely populated cities. Food and manufacturing must be localized to reduce energy use through transportation. International tariffs and interstate taxes will discourage international trade and promote local trade. Economies and cultures will be encouraged to localize. All of this will cause an unavoidable inflation on many types of goods. However even with that, an appropriately managed government will be able to make jobs that pay living wages available to the average person. People will realize with training that they must become more spiritual and less materialistic. Only the elites will travel the world. The Global Community will exist for most only through internet connection. People really will come to think globally while acting locally.

CONCLUSION: Freedom isn't given by government, people are born free. People need to be free as individuals. The only limits placed upon individuals should be those of their own lack of courage, ambition, or will power. Those of strong ambition, courage, and will power should be allowed to thrive and become the elite. All citizens should be equal under the law, but in truth people never will be completely equal. There will always be those in society who have greater or lesser benefits than the average person. However, those of inborn intelligence who act with strong will power to fulfill their ambitions should be free to do so. Democracy can't guarantee complete freedom for everyone because people will always be limited by their own mistakes or lack of determination. Many people don't really want freedom so much as just a chance to live a decent life. Democracy isn't utopia--and that's a good thing. Those who promise utopia are always liars. However, if organized properly, democracy can give the average person a fighting chance at a good life; and it's the only form of government which can do that."
